



**KHJA Board of Directors Meeting  
August 17, 2015  
Ballyhigh Show Stable 7 p.m.**

The regular meeting of the Kentucky Hunter Jumper Association was held at Ballyhigh Show Stable, Versailles Ky., on August 17, 2015. The meeting called to order at 7:17 p.m. by Joyce Brinsfield, president.

Guest speaker Cara Stewart of Kentucky Equine Education Project (KEEP) spoke about the lobbying and educational opportunities offered through KEEP. KEEP started a 501c3 foundation to raise funds they can then pay forward to grassroots organizations. The KEEP license plate features Seattle Slew and can be used in vehicles up to 10,000 pounds; they need 900 reservations (\$25/each) to go forward with printing. KEEP supports KHJA and is willing to do again; KEEP has given out \$650,000 in the last 10 years in grassroots funding. You can register for the plate online.

Last month KEEP approved a tax equity resolution; they want the horses to be similar to all other livestock. It is believed that this measure will impact the equine economy even more by removing the sales tax; more money to invest back into the industry.

Minutes were provided by Sarah Coleman, secretary/treasurer, and were read by attendees. Bruce Brown made a motion to approve the June 10, 2015 minutes. Ashley Watts seconded. All were in favor and the minutes were approved as read.

The award winner was chosen and will be awarded before the horse first goes into the ring at the 2014 KHJA Horse Show at the Kentucky Horse Park. Joyce Brinsfield and Diana Conlon will present the check to the winner. Photographs will be taken for the newsletter.

Joyce Brinsfield presented the Financial Committee report for Caroline Smith. Ray Current, the KHJA accountant is working on the audit.

Joyce Brinsfield reported on the Fall Classic Committee. Ribbon count has been completed. The prize list has been posted on the KHJA website. Coolers have been ordered. Farmhouse Tack has donated a gift certificate for every class; Ray Shultz and Jess Vacey was discusses as a show photographer.

Joyce Brinsfield and Ashley Watts presented on the Junior Committee. The Dog Show at the Robert Murphy July Show was a hit; it will become an annual event. A tour of KBC and Hallway are in the works for the late fall and winter. The Dirty Pony Contest was a success and well received. The conformation clinic given at Elaine Schott's River Mountain Farm was well received, though not well attended.

Joyce Brinsfield presented on the Bylaws Committee for Laura D'Angelo. No report.

Joyce Brinsfield reported on the Charity Committee for Nancy George. A run-in shed will be built for the Kentucky Equine Humane Center.
