Lynn Johnson presented at last board meeting to create incentive for local members to try rated shows

Several options – rule stated ... Local member will receive points based on the value of the show they show at. More points for rated shows up to 4 shows. Discussion about not fair for local members. Must compete in more local shows than regular shows. Best to spell out the rules. Majority of shows must be local. Vote on rule by show of hands, rule passes.

- Facebook – Board voted to shut down and issues brought to attention of board member or officer instead. Still want more involved membership. Need volunteers to help. Update website more.
- TIP – Thoroughbred incentive program – Elaine to report for Jockey Club. MET show managed by Arie on April 14-15 and TIP classes offered show responsible for checking breeding. Elaine – register your TB with the Jockey Club incentive program and have horse shows host classes and there is money and payback sponsorship. Deadline Nov 30<sup>th</sup>. TB challenge at rated shows selected horses to compete at big shows finals. Run Jump Win incentive program to promote TB in show ring. Match incentive programs funds. Several ways to prove lineage. 5 cross pedigree and must verify pedigree.

#### **Proposed rule changes in 2012 Rule Book effective immediately–**

- Pg 27 Q limit rider change blue ribbons – avoid cross entering limit rider and showing 3' jumpers – protect novice 2'6" riders. Riders may not have shown over 2'6" ever. At first sentence add have never shown higher than 2'6"
- Pg 28 R Baby green – eligibility is 2 yrs of showing at 2'6"
- Pg 28 T and U Pre adult and pre child – may not cross enter at the same horse show.
- Pg 28 V beginner horse and pony – have never shown 2'6 or higher eligibility 2 yrs may cross enter baby green.
- Pg 28 W beginner rider – including jumpers at the same show
- Pg 28 – Y – cross rails green horse and ponies – no points – higher than 2' may cross enter into beginner horse or rider and short and long stirrup. Trena suggests same suggestion to X – cross rail eq. except may cross enter into beginner rider only.
- Pg 28 – Z – may not enter into any 2' division or higher and remove B

Long stirrup div – needs definition not provided at this time

- Pg 30 - Annual meeting become separate from awards banquet and do it in November. Nominations, rules go into effect dec 1. The banquet will stay in jan with awards. Will be Nov 18<sup>th</sup>, 2012 for annual membership meeting.
- Pg 30 – strike part of 9 add part of 12. Make them follow USEF rules so first 2 classes not just first class anymore.

Jumpers will get championships if there are 3 or more classes in the division.

Add that there are no eq division champ or reserve.
